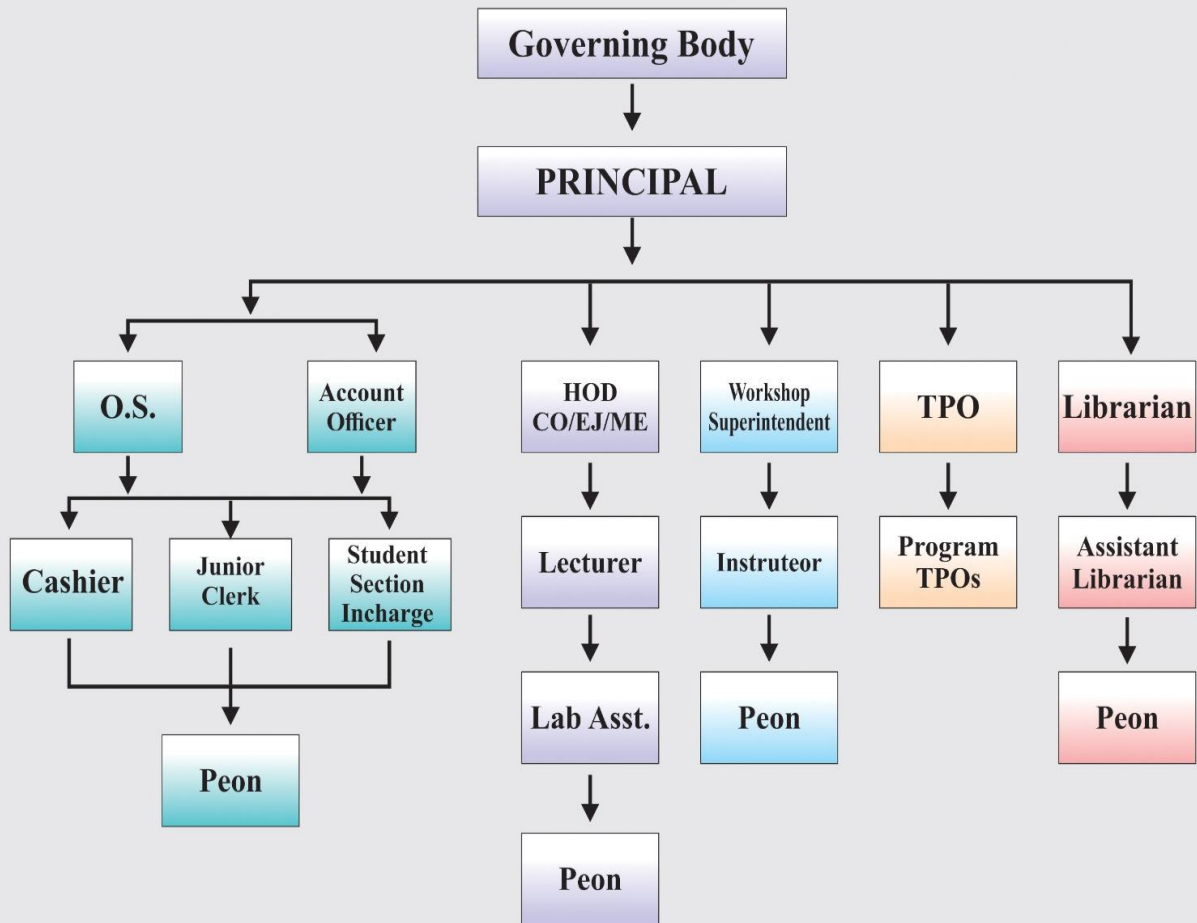

### **1.1 Admission Process**

- The admissions for First Year Post SSC Diploma Engineering and Direct Second Year Diploma Engineering are carried out as per the norms and schedule framed by the DTE from time to time.
- The admission process will be carried out through CAP-Round as per the norms & standards of
- DTE & Govt. of Maharashtra.

### **Eligibility conditions and requirements for admissions**

#### **\*First Year of Post SSC**

- The Candidate should be an Indian National.
- Passed 10th Std./SSC examination or its equivalent, with at least 35% aggregate marks.  
Note: Other than Maharashtra State Candidates shall be eligible for Institute quota only.

#### **\*Direct Second Year of Post SSC**

- The Candidate should be an Indian National;
- Passed 10+2 examination with Physics/ Mathematics /Chemistry / Computer Science /Electronics /Information Technology/ Biology / Informatics Practices/ Biotechnology /Technical Vocational subject/ Agriculture/ Engineering Graphics / Business Studies/Entrepreneurship (Any of the three).
